# **PRIVACY POLICY**

## 1. The information we collect

We collect the following information.

#### Information you provide us directly:

• Your e-mail address entered during registration on the website <u>https://together.thebell.io</u> hereinafter referred to as the "Website"

#### Cookies and similar technologies:

- When you visit the website, we may use cookies and other similar technologies to collect information about how you use the website and offer you the appropriate services.
- We may contact advertisers or other partners to provide ads or services to your device that may use cookies or similar technologies posted by us or third parties.

#### Information for the log file:

- Information for the log file is automatically transmitted by your browser every time you make a request to access (i.e. visit) the web page. It may also be provided when the content of a web page is downloaded to your browser or device.
- When you use the website, our servers automatically record certain information for the log file, including information about your requests, IP address and browser type; the page from which you entered the website; the page from which you left the website; page addresses, number of clicks and interaction with links on the Website; domain names, landing pages, viewed pages, and other similar information. We may also collect such information from e-mails sent to our Users in order to be able to track which messages were viewed and which links the recipient followed.

# **Device IDs:**

- When you use a mobile device (such as a tablet or phone) to access our Website, we may access your device's "ID" collect, track and store it on your device, and/or remotely store one or more device IDs. Device IDs are small data files or similar data structures that are stored on or associated with your mobile device and identify it as unique. The device identifier may be data that is stored in the device hardware; data that is stored in the operating system or other device software.
- The Device ID may provide us or a third-party partner with information on how you navigate the Website and use the Website, which may assist us or other parties in reporting or personalizing materials.

# 2. How we use information

In addition to some specific uses of information described in this Privacy Policy, we may use the information received to:

- help you quickly access your information after registration
- memorize information so that you do not have to re-enter it during the current or next visit to the Website;
- ensure, enhance, test and monitor the effectiveness of the Website
- track statistics: e.g. total number of visitors, traffic and demographic composition
- diagnose or correct technical problems
- automatically update the Website.

# 3. Transfer of your information

We do not provide or sell Your Information to third parties not related to the Website without Your consent, except as described in this Privacy Policy.

# The parties with whom we may share your information:

- We may transfer User Materials and information about you (including, but not limited to, information obtained through cookies, log files, device identifiers, website usage and location data) to companies that are legally part of the group of companies that includes the Website.

If you are in the European Union or other regions where the laws on the collection and use of information differ from the relevant laws in the Russian Federation, please note that we may transfer information (including personal) to a country or territory where data protection laws do not provide the same level of protection as the laws of your country or territory.
- By registering and using the Website, you agree to the transfer of information to the Russian Federation or any other country where the equipment of the hosting provider of the Website or Service Providers is located, as well as to the use and disclosure of information about you in accordance with the provisions of this Privacy Policy.
